Whereas the 2<sup>nd</sup> PARTY has desired and agreed to provide all required assistance, the details of which are mentioned below, in this regard to the 1<sup>st</sup> PARTY for smooth conduct of the courses as per the following terms and conditions.

- It is agreed that the 2<sup>nd</sup> PARTY will provide experienced coach and required equipment for training to the 1<sup>st</sup> PARTY.
- The 1<sup>st</sup> PARTY Faculty with the help of the 2<sup>nd</sup> PARTY will motivate students to take up the said badminton training course
- The 1<sup>st</sup> PARTY will also make sure that the students opting for the course will take admission as per the procedure laid down by the 1<sup>st</sup> PARTY.
- 4. This arrangement will be on responsibility sharing basis between the 1<sup>st</sup> PARTY and the 2<sup>nd</sup> PARTY as follows. The roles and responsibilities of the 1<sup>st</sup> PARTY and the 2<sup>nd</sup> PARTY are spelt out below:

## 5. Responsibilities of the PARTIES

## The 1st PARTY's responsibilities (Badminton Club, B.H.B. College)

The 1st PARTY will provide the detailed of training to the candidates well ahead of the commencement of the training.

The 1st PARTY will provide experienced coach to conduct the training.

The 1<sup>st</sup> PARTY will admit and register the candidates as per the norms and procedure laid down by the 1<sup>st</sup> PARTY.

The maintenance of training quality, training delivery and conduct of sports event is the responsibility of the 1<sup>st</sup> PARTY, and the 2<sup>nd</sup> PARTY will provide all possible support in this regard, such as providing resource persons, required equipment etc.

## The 2<sup>nd</sup> PARTY's responsibilities

The 2<sup>nd</sup> PARTY will provide instructors for taking practical classes as per requirement to help the instructors/resource persons belonging to the 1<sup>st</sup> PARTY.

The 2<sup>nd</sup> PARTY will provide equipment when necessary for training activities

The 2nd PARTY will help the 1st PARTY in conducting training as per requirements.

#### 6. Jurisdiction:

The court of the District and Sessions Judge, Bajali will be the jurisdiction.

7. Validity, Renewal and Termination of MOU

This MOU is valid till 5th Feb, 2026.

This MOU can be renewed further under similar terms subject to mutual agreement.

The MOU cannot be terminated before the validity period by any party.
